### Emergency Responses by Type:









### Response Time - EMS

### **Significant Incidents:**

Round Lake Crews were dispatched to 19 structure fires in May. Of these, 8 were in-district and 3 were significant.

---

#### **Tuesday, May 23<sup>rd</sup> @ 09:13 am (Gold):**

Crews were dispatched to the 100 block of W. Belvidere Road in Round Lake for a report of a structure fire. Battalion 26 arrived on scene first and reported smoke showing from the front door of a middle unit in the medium size strip mall occupied by "Lake Spa." Engine 261 arrived next and initiated an offensive fire attack through the front door. Upon entry, they were able to locate and extinguish a small fire in the front room of the massage spa. The building had a sprinkler system and the fire had been contained to the fire room by a single sprinkler head that activated.

The fire was brought under control in approximately 10 minutes and there was extensive smoke and water damage throughout the business. The adjacent occupancies on both sides of the Spa were unaffected by the fire. There were no injuries to civilians or firefighters.

Our crews were assisted by crews from Fox Lake, Grayslake, and Lake Villa at the scene. During the fire, calls in the remainder of the Fire District were covered by Antioch and McHenry.

#### **Sunday, May 28<sup>th</sup> @ 6:15 pm (Red):**

Crews were dispatched to the 50 block of E. Lake Park Avenue in Round Lake Beach for a report of a structure fire. Engine 263 arrived on scene first and reported a fully involved one-story detached garage with fire through the roof. There was an adjacent shed and fence that had caught fire and were also burning. E263 pulled an attack line and began a defensive attack on the fire. Engine 261 arrived next, and their engineer established a water supply while the remaining crew pulled a second hose line to extinguish the fire. Battalion 26 arrived, assumed command, and upgraded the alarm to the working still level to bring in resources to cover the remainder of the Fire District.



The fire was brought under control in approximately 30 minutes and while the garage and all contents were completely destroyed, crews were successful in protecting all adjacent houses. There were no injuries to civilians or firefighters.

Our crews were assisted by crews from Fox Lake, Grayslake, and Lake Villa at the scene. During the fire, calls in the remainder of the Fire District were covered by Antioch and McHenry.



**Tuesday, May 30<sup>th</sup> @ 1:44 pm (Black):**

Crews were dispatched to the 2500 block of N. Mallard Lane in Round Lake Beach for a report of a structure fire. Responding units reported they could see a large header of smoke from Station 1. Engine 262 arrived on scene first and reported a two-story, single-family residence with fire showing from all first and second floor windows and fire through the roof in the rear of the structure. It was quickly determined that all occupants were out of the building and a defensive fire attack declared. Engine 262 established a water supply, pulled a hose line to the rear of the structure, and began attacking the fire. Battalion 26 arrived next, assumed command in the front of the building and upgraded the alarm to the working still level initially and then to the box alarm level. E261 & E263 arrived on scene and pulled additional hose lines to attack the fire. The Quad 2 ladder truck was set up in the front of the building and attacked the fire with the master stream on the main ladder.



The fire was brought under control in approximately 1 hour and the house was completely destroyed. The adjacent houses on both sides of the fire both suffered melted vinyl siding due to the intense heat, but no fire damage. One resident of the home was treated for smoke inhalation but refused transport to the hospital. There were no injuries to firefighters.

Our crews were assisted by crews from Fox Lake, Grayslake, Lake Villa, Antioch, Spring Grove, Gurnee, Countryside, and Wauconda at the scene. During the fire, calls in the remainder of the Fire District were covered by Lake Zurich and McHenry.
